

## VESI Technical Training evidence guide - Apprentice Lineworker

Apprentice Lineworkers are trained to the Certificate III in ESI - Power Systems - Distribution Overhead Qualification. The Qualification is made up of units of Competence which are categorised as either Core or Elective units. Training for this Qualification is delivered by a Registered Training Organisation (RTO).

These units of competence incorporate training which may align with Technical Training required to be undertaken according to the VESI Skills and Training Guideline and Matrix.

The purpose of this guide is to assist the employer to understand where the VESI Technical Training aligns completely or partially to the unit of competence delivered during the Apprenticeship and to provide guidance to the RTO on the evidence required upon successful completion of a competency. Where additional gap training is required this could be delivered during the appropriate unit of competency.

The following table aligns the VESI Technical Training requirements, where applicable, to the Lineworker Qualification Units of Competence and specifies the required evidence including Statement of Results, Statement of Attainment to be provided by the RTO.

The employer shall record the initial VESI Technical Training in the ESI Worker System with the date aligned to the achievement of the applicable competency. The date in ESI Worker shall be used to determine the refresher training / competency period.

## VESI Technical Training evidence guide - Apprentice Lineworker

### Definitions

<b>Qualification Statement of Results</b>	Issued by the RTO to demonstrate successful completion of units of competence within the apprenticeship
<b>Statement of Attainment (SOA)</b>	Issued by the RTO confirming successful completion of National units of competence
<b>ESI Worker</b>	An individual's record of training where the entries are recorded electronically confirming successful completion of VESI Technical training
<b>VESI Technical Training</b>	Training which meets the requirements in the VESI Skills and Training Guideline and Matrix. Initial training can be Units of competence as stated in the matrix
